Checks are typically allocated and distributed at the end of the year and will be sent to the last known address for each member receiving service in the year being paid. Capital credits represent a significant source of equity for the cooperative and reflect each members' ownership in, and contribution to, the cooperative.

# Operation Round Up®

# **What is Operation Round Up?**

As a member of Steuben County REMC, you have a unique opportunity to make a difference in our local communities by participating in the Operation Round Up program. ORU is a voluntary charitable fundraising program for Steuben County REMC members to have their electric bill rounded up to the next whole dollar. ORU helps co-op members reach out to worthy causes in their communities and work together to help others.

### How does it work?

Members who participate in the program have their electric bill rounded up each month and those few cents are deposited into a separate fund to be redistributed to philanthropic and worthwhile causes throughout our area that benefit our membership. The rounded up amount will be listed on your statement each month and is fully tax deductible. Bill statements received in January will also have the previous years' total contribution for tax purposes. The maximum contribution from any one member is \$11.88 per year.

# **Operation Round Up**

# Who determines where funds go?

A separate volunteer board of directors, made up of three- toseven REMC members and two REMC employees administer the fund and set guidelines for the distribution of the contributions. The ORU board meets quarterly to discuss the grant applications, determine the impact on both the REMC membership and local community and allocate funds. Funded projects contribute to economic development and community benefit and are typically given to worthwhile philanthropic organizations throughout our area.

# Who is eligible for funding?

Any organization doing work within the Steuben County REMC service territory can apply for funding. The organization is not required to be a member of Steuben County REMC. Individuals are not eligible to apply. Funds will not be used to pay utility bills or any political contributions.

## How do I opt out?

# **Energy Evaluations**

FREE energy evaluations are available to help locate areas in your home that could be improved or changed in order to use electricity more efficiently and save money. For more information, please contact our office at **260.665.3563**.

### **A.O Smith Electric Water Heaters**

We offer 50-gallon high efficiency water heaters to our members at a significant discount (cash and carry). Tall (60" x 22") or short (50" x 24") sizes are available. Must be installed at a location serviced by the REMC. Members must agree to installation of a load management switch to be installed at a later date. Switch operates at peak usage times for short periods of time to keep overall power bills lower. Only one unit sold at discounted price for geothermal systems. Contact the office for pricing.

# Co-op Solar

Steuben County REMC members can choose to participate in the Co-op Solar program, a community solar initiative that allows you to purchase 'solar units' to utilize a renewable energy source. It alleviates the need to install rooftop solar units, taking away the upfront costs and maintenance fees. Contact the office for more information.

# **Area Lighting**

Dusk-to-dawn area lighting is available for a monthly charge. See rate schedule for more information. \$300 to set light pole and run wires (up to 150') if existing poles not available. Various styles available, contact the office for more information.

# **Tree Trimming/Used Pole Pieces/Tree Chips**

Contact Steuben County REMC for information on our tree trimming program or to report trees or brush in the electric lines that need attention. We also accept Christmas trees for chipping until the third week of January. Chips or used poles are free to members at the REMC office when available. For availability, contact the office and ask for the operations department.

# **Surge Suppression Products**

The Esktrom Surge Guard Surge Suppressor is placed at the electrical service entrance between the home and electric meter. It is designed to isolate your home from external events that affect power quality. See your rate schedule for more information.

### **Underground Electric Line Locating**

Steuben County REMC is affiliated with the Holey Moley program. Contact them for locates at **1-800-382-5544** prior to any digging or excavating, or dial **811** from your phone.

# **Life Support System Alert**

Members whose homes have life support equipment are identified, alerting the office in emergency outage situations and allowing for prior notification in instances of planned outages. Contact the operations department to learn more or set up.

# **Paying My Bill**

Steuben County REMC operates an Automated Metering Information system that wirelessly transmits your readings to the office. Meter readers or linemen may still stop by sporadically to ensure the functionality of your meter unit.

# **Billing**

Bills are mailed in three cycles and due the 5th, the 15th and the 25th of the month, depending on your location. **All bills are due monthly.** Return envelopes are provided with your bill for you to mail in your payment. Cash, check, VISA, MasterCard and Discover Card payments are accepted at our office location during business hours. We also have a 24/7 drop box located in our drive through for your convenience.

You may choose to pay your bill online with a credit card via our website at **www.remcsteuben.com** or by using the SmartHub app on your mobile devices or at **remcsteuben.smarthub.coop**.

# **Budget Billing**

Equalize your monthly bill by paying the same amount each month. Budget accounts are recalculated annually. Any credit or debit balance is rolled into the next budget year and the monthly budget amount is adjusted accordingly. For members who have been at the same location for at least 12 months. Begins in July of each year.

# **Automatic Payment Plan (ACH)**

Your monthly payments can be deducted automatically from your checking or savings account or a Visa, MasterCard or Discover Card at no charge to you for this service. **See the included form for details.** 

### **Collections**

After the payment due date, collection notices are sent and removals for non-payment are made. Once service has been disconnected for non-pay, extra fees are charged for reconnection.

If you are unable to pay your bill in a timely manner, please contact our office before the due date, and ask for the collections department.

# **If My Power Goes Out**

While we are committed to providing you with the highest level of reliability and satisfaction, you may experience occasional interruptions in your electrical service.

# **Before reporting your outage:**

- Check your home's fuses and breakers. If power is not restored, the issue may be with our system.
- Check your meter. If there is a digital reading on the face, the outage issue is at your home, not with our system.
- Check with your neighbors. If it appears they are also out of power, the problem is most likely with our system.
- Contact the office at 260-665-3563. Be sure to have your service location (not your billing address) and account number available.

# **Reporting Your Outage**

Despite operating a functional AMI system, all outages should still be reported to the office at **260-665-3563**. Have the service address and account number ready for quick and accurate reporting. Once you have reported your outage, please be patient as crews will be dispatched as soon as possible to resolve the issue. Repeated calls to the office are not necessary.

Emergency Services handles all after-hours calls. Outages will be relayed to standby outage crews. Emergency Services retains no records or authority to handle other matters, including billing inquiries and payments. For any matters other than outages, please call during regular business hours. Please note, you may be charged for callout on disconnected services or non-emergencies after business hours.

# **AUTOMATIC PAYMENT PLAN**



When you sign up for the Steuben County REMC Automatic Payment Plan (ACH), your utility bill payment is debited automatically from your checking/savings account, or your credit card each month.

With no more checks to write or due dates to stay on top of, your time is freed up to concentrate on the important things in life!

What are the benefits? The ACH plan is the most convenient way to pay your monthly electric bill. It is a service that saves you time and money. With the ACH plan you can avoid writing checks, paying for postage, mail delays and late charges.

How do I enroll? Complete the authorization form on the back of this insert. If using a checking account, please send a voided check with the form; if using a savings account, send a voided deposit slip; if using a credit card, please send only the signed form. Send all required information to the address listed on the bottom of the form.

What if I change bank accounts or want to cancel my ACH? To change banks/bank account numbers, or to change credit cards, please call the office at 260-665-3563 and ask for the ACH department. It's as easy as a phone call to make any changes.

How soon will the ACH plan start? It will take one full billing cycle before the ACH plan takes effect for checking/ savings accounts. For credit cards, it will take effect with your new due date. Banks take up to one full cycle to verify account information. Please continue to pay your bill manually until the mssage, "Bank Draft - DO NOT PAY" appears in the AMOUNT DUE section of your bill.
